

Certificate II in Automotive Servicing Technology AUR20520

COURSE DESCRIPTION & PATHWAYS:

This is a pre-apprenticeship course designed to provide the foundation qualifications reflected in the role of individuals who perform a range of servicing tasks in the automotive retail, service and repair industry.

This course can lead to an apprenticeship and career as an Automotive Mechanic, Automotive Electrician, Heavy and/or Light Vehicle Mechanic, Diesel Fitting and Engine Reconditioning, Marine Mechanic, Small Engine Mechanic or Motorcycle Mechanic.

VET for School Students – (VSS)

The AUR20520 Certificate II in Automotive Servicing Technology is supported by the Government of South Australia and is available for eligible VSS Students.

To be eligible for access to a subsidised training place, a school student must meet the following criteria.

They must be:

- An Australian or New Zealand citizen or,
- A permanent Australian resident or,
- An eligible visa holder
- Reside in South Australia

They must also be:

- enrolled in Year 11, 12 or 13 and be 16 years of age or turning 16 years of age in the current year of that enrolment, and
- undertaking SACE or equivalent and,
- have completed a preparatory VET pathway – please refer, VET for School Students Approved Evidence for Completion of a Relevant VET Pathway Guide, (available from your VET Coordinator)
- Whilst at school the secondary school student can access a total of one Certificate II course and one Certificate III course. If a secondary school student completes 70% of a course and exits without completion, they will consume one of their course entitlements.

Acceptance into a subsidised course will be determined through the VET Readiness Orientation process (VETRO). This will occur following receipt of a completed VET for School Student Referral to Training Form from the secondary school.
